Newid yn y trefniadau ar gyfer y Cyfarfod Blynyddol gyda rhieni
/ Changes in the requirement for an Annual Meeting with parents

O ganlyniad i Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013, a ddaeth i rym ar y 4^{ydd} o Fai 2013, nid yw'n ofynnol bellach i gyrff llywodraethu gynnal cyfarfod blynyddol i rieni. Y rhieni yw prif randdeiliaid y gymuned ysgol ac mae ganddyn nhw ddiddordeb clir a chryf yn addysg eu plentyn. Mae'n bwysig felly bod y corff llywodraethu yn ymgysylltu'n weithredol gyda rhieni ac yn parhau'n atebol trwy roi gwybodaeth a chyfleoedd iddyn nhw drafod a chael mewnbwn i'r ysgol.

Mae Deddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013 bellach yn galluogi rhieni disgyblion cofrestredig yn yr ysgol i ofyn am hyd at dri chyfarfod y flwyddyn gyda'r corff llywodraethu trwy gyfrwng deiseb. Darperir crynodeb byr isod. Rhaid i'r corff llywodraethu gynnal cyfarfod o fewn 25 niwrnod ysgol o dderbyn deiseb, cyn belled:

1. bod y ddeiseb yn cynnwys llofnodion yr isafswm angenrheidiol o rieni disgyblion cofrestredig yn yr ysgol, sef yr isaf o'r canlynol:

- (a) rhieni 10% o ddisgyblion cofrestredig, neu
- (b) rhieni 30 o ddisgyblion cofrestredig.

2. rhaid i'r cyfarfod y mae rhieni wedi gofyn amdano drafod mater sy'n berthynol i'r ysgol.
3. ni chaiff mwy na thri chyfarfod eu cynnal yn ystod y flwyddyn y derbyniwyd y ddeiseb gyntaf.
4. mae digon o ddyddiau ysgol ar ôl yn y flwyddyn ysgol i gynnal y cyfarfod.

Mae'r cyfarfod yn agored i holl rieni disgyblion cofrestredig yn yr ysgol, y pennaeth ac unrhyw berson arall a wahoddir gan y corff llywodraethu. Cyn gynted ag y mae'n rhesymol ymarferol, rhaid i'r corff llywodraethu hysbysu holl rieni disgyblion cofrestredig yr ysgol yn ysgrifenedig, beth yw dyddiad y cyfarfod, a'r mater i'w drafod.

As a result of the School Standards and Organisation (Wales) Act 2013, which came into force on 4th May 2013, a school governing body is no longer required to hold an annual parents meeting.

Parents are major stakeholders in the school community and have a clear and strong interest in their child's education. It is therefore important that the governing body actively engages with parents, and remain accountable, by providing them with information and opportunities to discuss and have an input into school.

The School Standards and Organisation (Wales) Act 2013 now enables parents of registered pupils at the school to request up to three meetings per year with the governing body via a petition.

A brief summary is provided below. The governing body must hold a meeting within 25 school days of receiving the petition, providing that:

- 1. The petition contains the signatures of the required minimum number of parents of registered pupils at the school, which is the lower of the following:
 - (a) Parents of 10% of registered pupils, or*
 - (b) Parents of 30 registered pupils.**
- 2. the meeting requested by parents must be to discuss a matter relating to the school.*
- 3. there will be no more than three meetings held during the year in which the first petition is received.*
- 4. there are sufficient school days left in the school year for the meeting to be held.*

The meeting is open to all parents of registered pupils at the school, the headteacher and any other persons invited by the governing body. As soon as reasonably practicable, the governing body must notify all parents of registered pupils at the school in writing, the date of the meeting and the matter to be discussed.

- Gosod targedau ar gyfer cyflawni disgyblion
- Sicrhau bod gan bob dysgwr fynediad at gwricwlwm eang a chytbwys
- Penderfynu a monitro cyllideb yr ysgol
- Staffio – e.e. apwyntiadau staff, rheoli perfformiad
- Rhoi gwybodaeth i rieni ynglŷn â'r ysgol
- Cynhyrchu cynllun gweithredu a monitro cynnydd yn dilyn archwiliad gan Estyn
- Lles a diogelu dysgwyr.
- Yn gyfrifol am baratoi adroddiad blynyddol i rieni ac am gynnal cyfarfod blynyddol gyda'r rhieni pan fo angen i drafod yr adroddiad ac unrhyw faterion eraill sy'n ymwneud â rhedeg yr ysgol

Mae disgwyl i bob Llywodraethwr fynychu cwrs hyfforddi sydd wedi ei drefnu gan yr AALl Cynhelir tri chyfarfod tymor yn ystod y flwyddyn. Yn ogystal, cynhelir cyfarfodydd rheolaidd ar gyfer Grwpiau Is-bwyllgor y Llywodraethwyr - cyllid, adeiladu, cwricwlwm, marchnata, personél.

Governors have to work closely with the Head teacher and Staff to ensure that the school runs smoothly and efficiently.

- *Promoting high standards of educational achievement and behaviour*
- *Setting targets for pupil achievement*
- *Ensuring that all learners have access to a broad and balanced curriculum*
- *Determining and monitoring the school's budget*
- *Staffing – e.g. staff appointments, performance management*
- *Providing parents with information regarding the school*
- *Producing an action plan and monitoring progress following an inspection by Estyn*
- *The wellbeing and safeguarding of learners.*
- *Are responsible for preparing an annual report to parents and for holding an annual meeting with the parents when needed to discuss the report and any other matters concerning the running of the school.*

Lleolir yr ysgol yng nghanol tref Llansawel. Mae'r dalgylch yn cynnwys tref Llansawel, Sgiwen, Baglan a'r Melin. Mae'n rhan o ardal weinyddol Cyngor Bwrdeistref Sirol Castell-nedd Port Talbot.

Daw ychydig o'r disgyblion o gartrefi lle mae un rhiant yn medru siarad yn y Gymraeg ac ychydig iawn lle mae dau riant yn siarad Cymraeg. Dynodir yr ysgol gan yr ALL yn ysgol Gymraeg, sy'n golygu mai'r Gymraeg yw prif gyfrwng yr addysgu, ond anelir at sicrhau bod y disgyblion yn rhugl yn y ddwy iaith erbyn iddynt drosglwyddo i'r ysgol uwchradd. Anelwn at feithrin yn y plant ymwybyddiaeth o Gymreictod a chariad tuag at wlad ac iaith.

Ysgol Gynradd Gymraeg Tyle'r Ynn is situated in the town of Briton Ferry. Its catchment area includes Briton Ferry, Baglan, Skewen and Melin. The school is part of Neath Port Talbot County Borough Council's administrative area.

A few children come from homes where one parent speaks Welsh, and very few from a home where two parents speak Welsh. The school is a designated Welsh school within the LA, where children are taught through the medium of Welsh, but we aim to make pupils bilingual in English and Welsh by their transition to secondary school. We aim to nurture in the children a pride in their country and its traditions and a love for its language and history.

Cysylltiadau â Rhieni / Links with Parents

Ymfalchiwn yn fawr fod yna bartneriaeth dda iawn yn bodoli rhwng yr ysgol a chi fel rhieni. Fel arfer, mae'r ysgol yn darparu tair noson agored i rieni ymweld â'r ysgol er mwyn trafod gwaith a datblygiad eu plant. Cynhelir un noson yn ystod Tymor yr Hydref, a'r Gwanwyn a'r llall ar ddiwedd Tymor yr Haf. Mae'r disgyblion yn derbyn adroddiad ysgrifenedig manwl yn flynyddol ar ddiwedd tymor yr Haf. Os oes angen dod i'r ysgol i drefnu cyfarfod gyda'r athro / athrawes / Pennaeth, mae modd cysylltu â'r ysgol i wneud trefniadau cyfleus.

Yn ystod Tymor yr Hydref yn flynyddol cynhelir cyfarfod - "Croeso i'r Dosbarth Newydd" - ar gyfer rhieni. Yn ystod y noson, ceir cyfle i gael gwybodaeth am waith y dosbarth yn ogystal â chyfle i holi'r athrawon perthnasol.

Mae'r rhieni yn gallu cysylltu â'r ysgol drwy alwad ffôn i'r swyddfa, ebost, neu drwy Dojo.

Ceir gylchlythyr wythnosol i hysbysu rhieni am newyddion a digwyddiadau yr ysgol.

We pride ourselves with the very good relationship that exists between the school and the parents of Ysgol Gynradd Gymraeg Tyle'r Ynn.

Normally, we would have three open evenings that are arranged every school year enabling the class teachers and parents / guardians to discuss the pupils' work and progress. One evening is held during the autumn and spring term and the other at the end of the summer term. Pupils receive detailed written reports once a year at the end of their academic year. Should parents wish to discuss anything with the teachers / head teacher, it is possible to contact the school to arrange a convenient appointment.

Early every autumn term, the school invites parents to school – "Welcome to the New Class" evenings.

During these evenings, parents meet the new teachers, receive information regarding the curriculum and receive an opportunity to ask relevant questions.

Parents are able to contact the school via telephone, email or Dojo.

Ymweliadau preswyl / Residential visits

CRAff ysgol / PTFa

Dymuna'r Corff Llywodraethu ddiolch i aelodau a swyddogion y gymdeithas am eu llafur caled ac i'r rhieni am eu cefnogaeth a'u haelioni. Mae angen parhau â'r gefnogaeth wych yma er mwyn trefnu mwy o weithgareddau ac er mwyn denu to newydd o rieni i'n plith. Diolch i 'Ffrindiau'r Ysgol' am roi cyfraniad sylweddol i'r ysgol er mwyn prynu cyfoeth o lyfrau darllen newydd sydd o ddiddordeb i'r plant.

The Governing Body wishes to express its gratitude to the members of the 'Friends of the school' for their hard work and to the parents for their continued support and generosity. The 'Friends of the school' requires continued support in future, enabling them to arrange events that are more social and to encourage a new generation of parents to become involved. This year the 'Friends of the school' have donated a generous sum of money that

has allowed us to buy new reading books that are both interesting and enjoyable for the children.

Yfed a Bwyta'n Iach / *Healthy Eating and Drinking*

I atgyfnerthu'n nodau chwaraeon, mae'r ysgol yn hyrwyddo bwyta ac yfed iach ac anogir disgyblion a'u rhieni i fwyta'n iach. Dosbarthwyd taflenni i ddisgyblion a'u rhieni, yn eu hannog i ddarparu blychau cinio iach. Paratwir bwydlenni ar lefel Awdurdod sy'n sicrhau'r lefel gywir o faeth. Anogir disgyblion i yfed dŵr wrth weithio ac y maent yn ymwybodol o bwysigrwydd hydradiad y corff. Mae ffrwyth ar gael yn ddyddiol i bawb.

To complement the school's sporting aims, the school promotes healthy eating and drinking, pupils are encouraged to eat healthily. Leaflets have been distributed to pupils and parents encouraging them to provide healthy lunch boxes. School menus are prepared at Authority level to ensure the correct nutrition level. Pupils are encouraged to drink whilst working and are aware of the importance of remaining hydrated. Fruit is available on a daily basis to all.

Anghenion Dysgu Ychwanegol / *Additional Learning Needs*

Daeth y côd newydd ADY i rym ym Medi 2022. Mae'r ysgol wedi dechrau gweithio i gydymffurfio â'r côd newydd.

Mae'r sbectrwm a gynhwysir o fewn anghenion arbennig yn eithriadol o eang, o blant â datganiadau swyddogol i blant eithriadol o ddisglair sy'n teilyngu gwaith ymestynnol i gadw eu diddordeb a datblygu eu galluoedd.

Gan fod sbectrwm o anghenion arbennig yn yr ysgol, rhaid darparu sbectrwm o ddarpariaeth arbenigol i ateb anghenion y plant. Bwriadwn i bob disgybl elwa'n llawn o'i gyfnod yn Ysgol Gymraeg Tyle'r Ynn; rhaid felly darparu'n llawn ar gyfer pob angen a gosod strwythurau yn eu lle i fonitro a darparu ar gyfer yr anghenion hynny.

Polisi cyffredinol yr ysgol yw gweithredu o fewn cysyniadau canolog, trawsgwricwlaidd tymhorol. Addysgir plant mewn dosbarthiadau o allu a rhyw cymysg ymhob blwyddyn yn yr ysgol.

Mae gennym 5 plentyn ar CDU Awdurdol Lleol, 14 ar CDU ysgol, a 27 o blant ar daflen targedau / rhestr fonitro. Bydd cynorthwyrwyr addysgu yn cynorthwyo grwpiau bychain o blant gyda'u targedau.

Mae polisi Addysg Dysgu Ychwanegol yr ysgol yn cydymffurfio â Chôd Ymarfer yr Awdurdod Addysg Leol. Mae'r polisi yn cael ei adolygu'n flynyddol gan y Cydlynnydd ADY.

Mrs Morgan yw'r cydlynnydd ADY.

The new ALN bill came in to force in September 2022. The school has begun to work towards this new bill.

The spectrum included within Additional Learning Needs is very wide indeed, from children with an official statement to exceedingly bright children who deserve extension work to maintain their interest and develop their abilities. As there is a spectrum of Additional Learning Needs in the school, a spectrum of specialist provision must be made available to meet the needs of the children. We intend every pupil to profit fully from his/her period at Ysgol Gynradd Gymraeg Tyle'r Ynn; full provision must therefore be made available for every need and structures put in place to monitor and provide for those needs.

The general policy of the school is to work within termly, cross-curricular central themes.

The children are educated in mixed ability and gender classes in every year at the school.

5 children hold LA maintained IDP's, 14 have school maintained IDP's and there are 27 children who access our inclusive learning provision. By now, support is provided for children with Additional Learning Needs within the classroom environment. Learning Support Assistants work with small groups of pupils on their targets.

The school's Additional Learning Needs policy fully complies with the Local Education Authority's Code of Practice. Mrs Nerys Morgan is the ALN coordinator, and the policy is reviewed annually.

Amddiffyn Plant / Child Protection

Swyddog Amddiffyn Plant yr ysgol yw'r Pennaeth gweithredol Mrs Lisa Cox a Mrs Nerys Morgan yw'r dirprwy swyddog dynodedig. Ar gyfer y flwyddyn Mrs Helen Clarke oedd cynrychiolydd y Corff Llywodraethu i gydweithio gyda'r ysgol parthed materion amddiffyn plant. Adolygir y polisi a'r gweithdrefnau yn flynyddol. Mae holl staff yr ysgol wedi diweddarau'u hyfforddiant Diogelu Plant gan y pennaeth.

The Acting Headteacher Lisa Cox is the designated Child Protection Officer for the school, Mrs Nerys Morgan is the deputy child protection officer. Mrs Helen Clarke was appointed as the Governors representative for the year to work alongside the school. All staff have received update training in Child Protection from the headteacher.

Cyfleusterau i rai ag Anabledd / Provision for the Disabled

Ein nod yw creu cyfleoedd cyfartal i bawb. Ceir rhai cyfleusterau i'r anabl ar y safle. Mae'r Corff Llywodraethu wedi llunio Cynllun Cydraddoldeb Strategol a Chynllun Mynediad sy'n cynnwys targedau tymor byr a hir dymor.

It is our aim to create equal opportunities for all. The school has some facilities for the disabled. The School's Governing Body has prepared a Strategic Equality and Access Plan that includes short and long term targets.

Prospectws yr Ysgol / School Prospectus

Adolygwyd prospectws newydd yr ysgol gan gynnwys llawlyfr i rieni a gwnaed mân newidiadau i adlewyrchu dyddiadau a staffio'r ysgol ar gyfer y flwyddyn ysgol 2024/2025. Yn unol â rheolau statudol, dosbarthwyd y llawlyfr yma i rieni plant sy'n cychwyn addysg llawn amser yn yr ysgol bob Medi. Gellir cael copi o'r llawlyfr yma o'r swyddfa neu wefan yr ysgol. *The school's new prospectus including a new School Handbook for parents for the academic year 2024/2025 was reviewed and amended with small changes to dates and staffing. To comply with statutory regulations a copy of the school prospectus is issued to parents / guardians of pupils commencing full time education as from September every year. Copies of the prospectus are available from the school office or our website.*

Y Cyngorau Ysgol / School Councils

Corff wedi ei ethol yn ddemocrataidd yw'r cyngor ysgol a'r is bwyllgorau. Mae aelodau'r cyngor yn cael eu hethol gan eu cyd-ddisgyblion i gynrychioli eu dosbarth ar y cyngor. The school council and its sub committees are a body of pupils that have been elected democratically. Members are elected by their fellow pupils to represent the class. The council meet regularly with members of staff to discuss school related issues and projects and to arrange fund raising events.

Safonau addysgu a dysgu / Standard of teaching and learning

Caiff safon yr addysgu a'r dysgu ei monitro'n gyson gan y cydlynwyr pwnc, arweinyddion tîm a'r pennaeth. Derbyniodd yr ysgol gymhorthdal drwy'r Gronfa Gwella Addysg. Defnyddir y grant yma i hyrwyddo datblygiad proffesiynol aelodau'r staff a datblygiadau arbennig yn rhaglen gwella'r ysgol. Yn ystod y flwyddyn ddiwethaf mynychwyd nifer o gyrsiau gan y staff, ac mae'r wybodaeth a dderbyniwyd wedi ei chynnwys yng nghynlluniau a dulliau dysgu'r ysgol.

The standard of teaching and learning is monitored systematically by subject co-ordinators, team leaders and the head teacher. The school received financial support from Education Improvement Grant. This grant is used to augment the professional development of

members of staff and for special developments in the school improvement programme. Staff members attended a number of courses over the last academic year and the information gained has been included in the school's schemes of work and teaching styles.

Adolygu Polisiâu'r Ysgol / Review of School Policies

Cyfleusterau tai bach/*Toilet facilities*

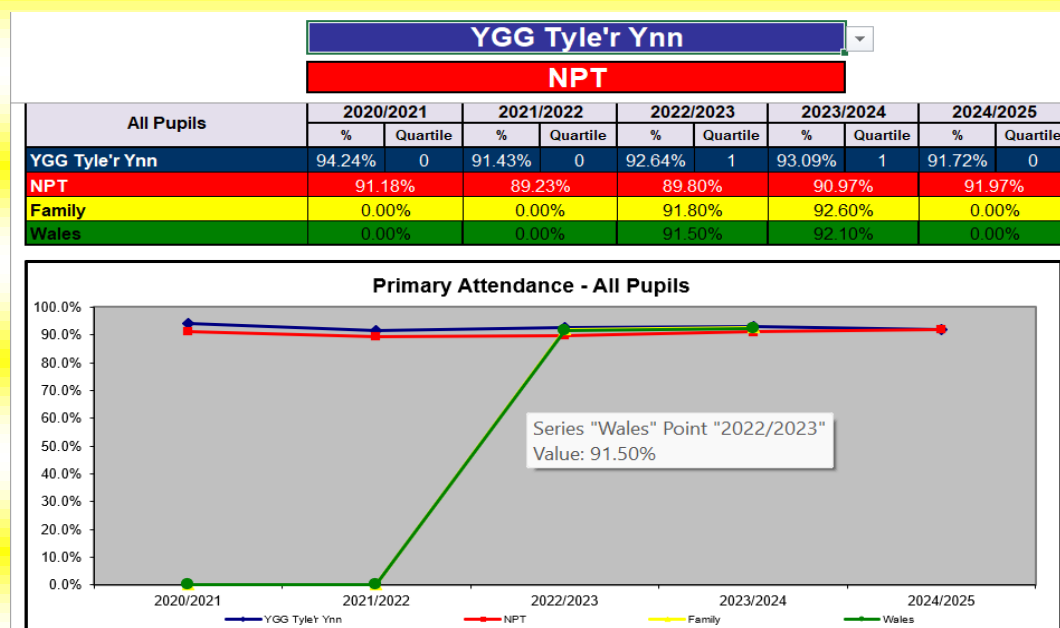

There are 18 toilet cubicles and 6 urinals located in the three separate buildings of the school. The toilets are appropriate to the age of the children who use them. There is 4 additional toilet for the exclusive use of school staff and visitors. All toilet areas are cleaned on a daily basis.

Targedau Presenoldeb/*Attendance targets*

The school has targets to improve attendance and parents and pupils have a crucial part to play in meeting these targets. For a number of years, our target has been 95%. The pandemic has certainly affected targets and attendance levels of all schools over the last year and a half.
