# Rights of the Child

Children and Young People have 42 rights under the United Nations Convention on the Rights of the Child (UNCRC).

The 42 Rights give children the opportunity to grow up happy, healthy and safe.

At Baglan Primary School, we foster a Children's Rights-Based Approach.

The 7 principles of a Children's Rights Approach are:

- Dignity All children at Baglan Primary School are treated with care and respect in all circumstances.
- Interdependence and Indivisibility Our Rights Respecting Group make children aware of their rights and ensure they know that all rights are equally important.
- Best Interest At Baglan Primary School, we ensure all decisions are made with the input, and best interest of the child(ren) in mind.
- Participation We encourage children to participate in all aspects of school life, including actively participating in designing their own curriculum.
- Non-discrimination We foster an environment of equality and diversity and teach, and encourage our children to be ethical, informed citizens.
- Transparency and Accountability At Baglan Primary School, we as staff and governors hold ourselves accountable for how children experience their rights.
- Life, Survival and Development Every child has the right to life and to be safe and happy. We help our children develop physically, mentally, socially and emotionally.

#### Introduction

RSE is a positive and protective part of the Curriculum for Wales. It plays a central role in supporting learners' rights to enjoy fulfilling, healthy and safe relationships throughout their lives.

Central to the Curriculum for Wales is an aspiration for every child and young person to achieve the four purposes of the curriculum. A rights and equity based RSE curriculum helps ensure that all learners can develop an understanding of how people's faith, beliefs, human rights and cultures are related to all aspects of RSE and how these rights can contribute to the freedom, dignity, well-being, and safety of all people. Therefore, within Baglan Primary School, we will discuss RSE in the context of the rights protected by the United Nations Convention on the Rights of the Child.

RSE at Baglan Primary School will support pupils to develop the knowledge, skills and values to understand how relationships and sexuality shape their lives as well as the lives of others. Pupils will be equipped and empowered to seek support on issues relating to RSE and to advocate for themselves and others.

RSE is a mandatory requirement in the Curriculum for Wales for all learners from age 3 to 16. This means that all learners must receive this education. There is no right to withdraw from RSE within the Curriculum for Wales.

This policy has been written to link with other school polices and processes at Baglan Primary School. These include:

#### Aims and Objectives of RSE

The aim of RSE at Baglan Primary School is to give young people the information they need to help them develop healthy, nurturing relationships of all kinds. It should enable them to identify a healthy relationship and what makes a good friend, a good colleague and a successful marriage or other type of committed relationship. It should teach what an acceptable and unacceptable behaviour in relationships is.

In accordance with legislation, RSE at Baglan Primary School will be inclusive, pluralistic, factually correct and provide opportunities for learners to critically engage and respond to all areas of the RSE curriculum. Staff will be well trained and all resources used will be carefully selected in line with the needs of the learners.

The learners in Baglan Primary School will be supported to understand and appreciate how the different components of health and wellbeing are interconnected, and it recognises that good health and well-being are important to enable successful learning. RSE will be taught through a range of spotlight lessons through the health and well-being area of learning.

#### Co constructing with Pupils

In accordance with the United Nations Convention for the Rights of the Child, learner voice will be used to support in constructing the RSE curriculum at Baglan Primary School and learners will regularly have opportunities to evaluate and review our RSE provision to ensure that it effectively meets their needs.

#### Working with Parents and Carers

All parents/carers will be kept informed about the provision of RSE at Baglan Primary School and will be encouraged to see RSE as a shared responsibility between school and home.

#### Working with Visitors and External Agencies

When visitors and external agencies provide sessional learning opportunities for learners, the school will ensure that:

- The school and the external provider have agreed the aims, content and approach to be adopted.
- The local authority (education department) know of and have approved the agency as a provider of RSE support within schools.
- The school has made the provider aware of any relevant school policies.
- The school has informed and prepared pupils ahead of the visit and allowed them time to prepare questions.
- Schools who commission external agencies will apply and follow the safe recruitment and commissioning procedures of the local authority.
- The school has planned for the provider to be actively supported by a teacher throughout the visit.

#### Developmentally appropriate RSE

The Act requires that the RSE provided must be developmentally appropriate for learners. Therefore, schools and settings must take account of a range of factors such as the learners age, knowledge and maturity and any additional learning needs. RSE at Baglan Primary School will be developmentally appropriate for each learner. The age of learners should be one of the criteria by which practitioners decide upon the appropriateness of content; however, there will be other factors they will need to consider when planning provisions. Factors such as the physical and mental and emotional development of learners should also be taken into account. This is essential to ensuring learners are kept safe from information for which they are not sufficiently mature to process. This, however, should not be a reason for not providing children and young people with the essential information they need as they develop physically, mentally, and emotionally; developmentally appropriate RSE requires the coverage of subjects that are integral to learners' development. For example, issues which may affect some younger learners, such as puberty, menstruation, should be engaged with sensitively and before the onset of physiological changes. We will also consider how appropriate support is provided through a whole school approach such as, in the case of puberty, ensuring that learners have access to sanitary products.

### Monitoring of RSE

Although RSE is a whole school responsibility, RSE will be monitored, reviewed and evaluated by those with a responsibility for RSE at Baglan Primary School, in line with the school's curriculum policy. This includes:

- The representative from the Governing body with responsibility for RSE
- The Headteacher and Senior Leadership Team
- The RSE lead
- Learners

The RSE policy will be reviewed every year and this process will include all of the above, alongside other members of our school community (parents/carers, the Governing body and learners) to ensure that our RSE provision and curriculum is effective in meeting statutory requirements.
